## Licences, Permissions and Insurance

Special licences are required for the sale of certain products such as alcohol.

Failure to acquire these licences or permissions could result in fines or the closure of your business.

If you employ staff you are legally required to have Employer's Liability Insurance and if the public or suppliers visit your premises you will also need Public Liability Insurance.
